## 13.0 THE GOVERNMENT ACTUARY'S DEPARTMENT

## 13.1 Actuarial guidance

In accordance with Regulation 2(3)¹ of the LGPS Regulations 2013 the Secretary of State for the Department for Communities and Local Government (DCLG) is required to issue actuarial guidance to the administering authority after consultation with the Government Actuary's Department (GAD). Throughout the regulations there are many occasions that require actuarial guidance to be issued so that administering authorities can carry out their duties in line with those regulations.

Details of the current guidance issued by GAD and how they relate to the statutory regulations can be found in Table 12 below. All GAD guides can also be found on the <u>Local Government Association</u><sup>2</sup> website.

It is important to be aware that GAD also issued a paper headed 'Local Government Pension Scheme – England & Wales – Miscellaneous Amendments to Guidance – November 2014' to be used in conjunction with the guidance documents.

Please note that in certain circumstances where a former scheme member has perhaps left the Scheme under earlier regulations, older versions of particular GAD guidance may need to be referred to by the pension administrators.
